
ARTICLE XII

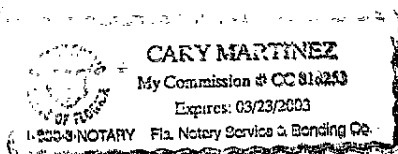
