

ARTICLE I. NAME

The name of the corporation shall be BELLON AND MILANES ARCHITECTS INC..

The principle place of business of this corporation shall be at 13200 S.W. 128 Street, Bldg. G, Miami, Fl. 33186.

ARTICLE II. NATURE OF BUSINESS


