The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be Perry's Beauty Salon, Inc.

**ARTICLE II - COMMENCEMENT & DURATION**

The corporation shall commence its existence on February 15, 2001 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE V - REGISTERED AGENT

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
