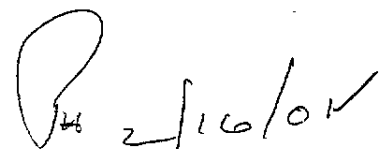

ARTICLES OF INCORPORATION OF WORLD-WIDE WATER RECYCLING, INC.

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

Article 1. **Name.** - The name of the corporation shall be "WORLD-WIDE WATER RECYCLING, INC."

Article 2. **Address.** - The initial address of the corporation shall be as follows:

Article 3. **Nature of Business.** - The corporation may engage in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other state. 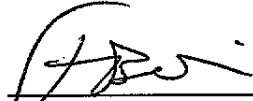
