The general purposes for which the corporation are engaged are:



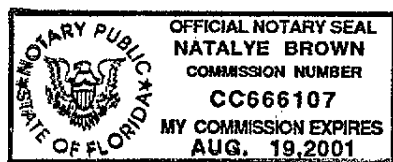
