ARTICLE I. CORPORATE NAME

The name of this corporation is Empire Maintenance, Inc..

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of this business is a company providing services for the maintenance and cleaning of commercial properties.

ARTICLE III. CAPITAL STOCK

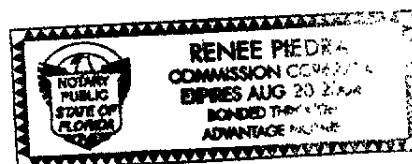


