Articles of Incorporation

SECRETARY OF STATE TALLAHASSEE FLORIDA

We, the undersigned, hereby form, organize and incorporate under the laws of the State of Florida, by and under the provisions of the statues of the State of Florida providing for the formation, liability, rights, privileges and limitations of corporations for profit, the above named corporation.

Article I: The name of this corporation shall be Euro Natural Products, Inc.

Article II: The corporation may engage in any activity or business permitted under the laws of the Unites States and of the State of Florida.

Article III: The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is one hundred (100) shares having a one dollar (\$1.00) par value.

Article IV: This corporation is to have perpetual existence.

Article V: The principal place of business of this corporation shall be 10222 NW 50 St., Sunrise, FL 33351 or in any other location in the State of Florida designated by the board of directors.

Article VI: This corporation shall have three (3) directors. The number of directors may be increased or decreased from time to time in accordance with the terms and conditions of the bylaws adopted by the stockholders, but shall never be less than one (1).

Article VII: The name and addresses of the first board of Directors who, subject to the provisions of the certificate of incorporation, the by-laws, and the corporation laws of the State of Florida, shall hold office for the first year of the corporation's business and existence, or until their

successors are elected and have qualified are: Daniela Tynan, 10222 NW 50 St., Sunrise, FL 33351, Gustavo A. Tobon, 13873 SW 102 Terrace, Miami, FL 33186 and Volker Kracht, 10222 NW 50 St., Sunrise, FL 33351

Article VIII: The executive officer of this corporation shall be the president. Any person may hold two offices. The corporation may also have such officers and agents as may be deemed necessary and all such officers and agents shall be chosen in such manner, take and hold their offices for such terms, and have such powers and duties as may be prescribed by the by-laws, or determined by the board of directors.

Article IX: The corporation reserves the right to amend, alter, change, or repeal any provision contained in these article of incorporation in the manner now or hereafter prescribed by law, and all rights and powers conferred therein upon stockholders, directors and officers are subject to this reserved power.

Article X: Every person who is now a director or who shall hereafter become a director of this corporation, shall be indemnified by the corporation against all costs and expenses (inclusive of legal fees) hereafter reasonably incurred by reason of their being a director of this corporation. The provisions of the statutes of the State of Florida in regards to indemnification shall govern the extent of this right to indemnification.

Article XI: The corporation desiring to organize under the laws of the State of Florida, hereby designates 10222 NW 50 St., Sunrise, FL 33351 as its registered office and agrees to maintain same at all times, and further designates Daniela Tynan of said address as its registered agent to accept service of process within the State of Florida.
