ARTICLES OF INCORPORATION

FOR

JOYCE NAILS, CORP.



I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be JOYCE NAILS, CORP.

ARTICLE II

This corporation may engage in and transact any activity or business for which a corporation may be incorporated under the Florida General Corporation Act. The principal office address is at 13900 SW 160th Avenue, Miami, Florida 33196.
