The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

The name of this corporation is Landtroop Freelance Services, Inc.

This corporation shall have perpetual existence.

This corporation is organized for the purpose of transacting any or all lawful business.

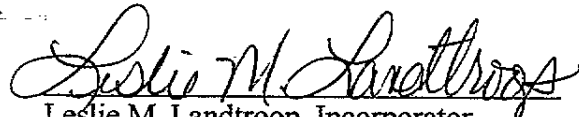
**ARTICLE VIII - INDEMNIFICATION**

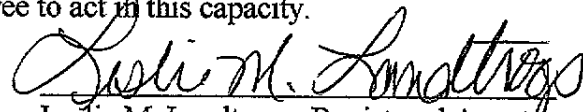
