The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE ONE (Name) The name of the corporation is MADAN CATERERS, INC. The principle place of business is 130 S.W. 3rd Ave., Dania Beach, Fl 33004.

ARTICLE TWO (Duration) The date and time of commencement of corporate existence is concurrent with the time of filing Articles of Incorporation by the Department of State.

ARTICLE THREE (Purpose). The purposes for which the corporation is organized, are to organize, conduct, promote, sell and cater to individuals, companies or organizations on a buy, sell or charter basis, and to engage in any activity within the purposes for which corporations may be organized under the Florida General Corporation Act.

ARTICLE FOUR (Capitalization) - The aggregate number of shares which the corporation shall have authority to issue shall be one thousand, which shares shall be common stock at a par value of one dollar (\$1.00) each.


