**ARTICLES OF INCORPORATION OF**  
**R/C PLASTIC PLANES, INC.**

**ARTICLE I. NAME**

The name of this corporation is R/C Plastic Planes, Inc.

**ARTICLE II. PRINCIPAL OFFICE**

The street address of the principal and initial registered office of the Corporation is 2300 West Union Circle, Deltona, Florida 32725.

**ARTICLE III. PURPOSE AND NATURE OF BUSINESS**

The purpose of this corporation and the nature of its business are to manufacture, distribute and sell to the public Remote Control Planes through the Internet, phone sales, Distribution Centers and public appearances.

**ARTICLE IV. CAPITOL STOCK**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 7500 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock. No holder of stock in this corporation shall enter into any type of agreement vesting another person with the authority to exercise any of that stock holder's voting power in this corporation.

**ARTICLE V. INITIAL OFFICERS/DIRECTORS**

The Corporation shall be managed by a Board of Directors of at least (3) Directors. This number may be increased or decreased from time to time by amendment to these bylaws, but no decrease shall have the effect of shortening the term of any incumbent director. No person shall serve as a Director of the Corporation unless the individual is 18 years of age or older but need not be residents of Florida or shareholders of this corporation. The Directors shall be elected by the shareholders of the Corporation. The name and street address of each person who is to serve as a member of the initial board of directors is as follows:
