ARTICLE ONE

The name of the corporation is **The Liquidealer, Inc.** The principal address of the corporation is: 6250 SW 18 Place Pompono Beach, FL 33068.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**

ARTICLE FIVE


ARTICLE EIGHT
