ARTICLES OF INCORPORATION FOR

DATEKSA, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation shall be:

DATEKSA, INC.

ARTICLE TWO

The principal place of business and the mailing address of this corporation shall be:

ARTICLE THREE

This corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United States and of the State of Florida. The specific purpose for which the corporation is organized is:

- a) The development of computer software, the import and export of computer peripherals, barcode scanners, mobile computing equipment and other computer software and hardware for sale to business and the general public,
- b) To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description.
- c) To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses in the State of Florida, and in all other states, districts, territories, countries or colonies.
- d) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such

mortgages, transfer of corporate property or other instruments to secure the payment of corporate indebtedness as required.

- e) To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of or deal in and with any of the shares of the capital stock or any voting trust certificates in respect of the shares of capital stock, scrip warrants, rights, bonds debentures, notes, trust receipts, and other securities, obligations, chose in action and evidence of indedtness or interest issued or created by any corporation, joint stock companies, syndicates, association firms, trusts, or persons, public or private, or by the government of the United States of America, or by any foreign government, or by any state, territory, province, municipality or other political subdivision or by any governmental agency, and as owner thereof, to possess and exercise all the rights, powers and privileges of ownership, including the right to execute consents and vote thereon, and to do any and all acts and things necessary or advisable for the preservation, protection, improvement, and enhancement in value thereof.
