ARTICLE I

Corporate Name and Principal Office

The name of this corporation is <u>The Palms Resort</u>, <u>Incorporated</u> and its principal office and mailing address is <u>140 Shell Harbour Road</u>, <u>Satsuma</u>, <u>Florida 32189</u>

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on February \$5, 2001.

ARTICLE III

General Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States or of the State of Florida.

ARTICLE IV

Common Capital Stock
