**ARTICLES OF INCORPORATION  
OF  
YTHAP, INC.**

**ARTICLE I - NAME AND ADDRESS**

The name of this corporation is **YTHAP, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 400 East Palm Avenue, Tampa, FL 33602.

**ARTICLE II - PURPOSE**

The Corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE III - CAPITAL STOCK**

The aggregate number of shares which the Corporation shall have authority to issue is One Hundred (100) shares of common stock, all of which are to have a par value of Ten Dollars (\$10.00) per share. 
