ARTICLES OF INCORPORATION
of

THE UNDERSIGNED, acting as the sole incorporator of **Spurlin Holdings, Inc.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of **Spurlin Holdings, Inc.** for such corporation:

ARTICLE I

Name and Address


