ARTICLES OF INCORPORATION

OF

SHEMANSKY CHIROPRACTIC, P.A. A PROFESSIONAL CORPORATION



The undersigned, being duly licensed to practice chiropractic medicine in the State of Florida, desires to form a professional corporation in accordance with Chapter 607 and Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation Act, and adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is Shemansky Chiropractic, P.A.

ARTICLE II. REGISTERED OFFICE AND AGENT AND PRINCIPAL OFFICE

The location and address of the Corporation's initial registered office in Florida and the Corporation's principal office is 25195 S. Tamiami Trail, Bonita Springs, Lee County, Florida 34135. The initial registered agent at the registered office is Chip Shemansky.
