The undersigned incorporator to these Articles of Incorporation, all of whom are duly licensed and competent to contract for the Creation, Production, Development and Distribution of original Videos, DVDs, CD Roms and all other audio and video technologies and for every and all other Legal Purposes, forms a corporation for profit pursuant to the provisions of the Florida Business Corporation Act and other laws of the State of Florida.

ARTICLEI

<u>Name</u>

The name of this corporation is: Notions Network, Inc.

ARTICLE II

Existence

The corporation's existence shall commence on February 22, 2001.

ARTICLE III

Nature of Corporate Business and Powers

The general nature of the business to be transacted by this Corporation shall be:
