ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporations Act, adopts the following Articles of Incorporation for such corporation:

1. Name. The name of the corporation is The Law Offices of Richard La Belle, P.A.
2. Principal Office/Mailing Address. The principal office of the corporation is 3446 Lake Drive, Palm Harbor, Florida, 34683. The mailing address is the same.
3. Commencement of Existence. The existence of the corporation will commence on the date of filing of these Articles of Incorporation.
4. Purpose. The corporation is organized to engage in the practice of law.

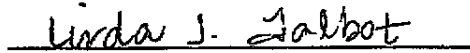

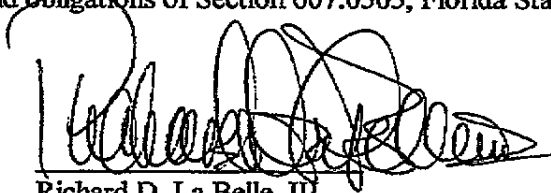
