ARTICLES OF INCORPORATION
OF
SOUTHERN UTILITY EQUIPMENT & REPAIR, INC.

The undersigned incorporators deliver these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act, and hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be SOUTHERN UTILITY EQUIPMENT & REPAIR, INC. The principal place of business of this corporation shall be 1507 Iowa Place, Orlando, FL 32803 and the mailing address of the corporation shall be the same.

ARTICLE II
CORPORATE PURPOSES, POWER AND RIGHTS

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

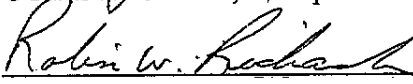
