The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation (hereinafter referred to as the "Corporation") is Frank Anzalone, Inc.

**ARTICLE II  
PRINCIPAL OFFICE**

The principal office of the Corporation is 9401 S.W. 49<sup>th</sup> Street, Cooper City, FL 33328, or in any other city in the State of Florida designated by the Board of Directors from time to time.

**ARTICLE III
