ARTICLES OF INCORPORATION

OF

ENVISIONS INTERIORS, INC.

<u>ARTICLE I - NAME</u>

The name of the corporation is Envisions Interiors, Inc. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE
