# ARTICLES OF INCORPORATION FOR

HINES ELECTRICAL, INC.

#### ARTICLES I. NAME

The name of the corporation shall be:

Hines Electrical, Inc.

The principal place of business of the corporation shall be 2198 N.E. CR 337, High Springs , Florida 32643.

## ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawfull activities or business permitted under the laws of the United States, the State of Florida or any other state, country or nation.

# ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$1.00 par value per share.

#### ARTICLE IV. ADDRESS

The street address of the initial registered office of the corporation shall be 2198 N.E. CR 337, High Springs, Florida. and the name of the initial registered agent of the corporation at that address is Mervin L. Hines.

## ARTICLE V. BOARD OF DIRECTORS
