ARTICLES OF INCORPORATION

OF

FIRST: The undersigned, (incorporator), whose address is 38 Woodland Street, Hartford, Connecticut 06103, does hereby adopt the following Articles of Incorporation for the purpose of forming a professional corporation (hereinafter called the "corporation") in the State of Florida, under the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, and the General Laws of the State of Florida.
