Enclosed please find the 2006 For Profit Corporation Annual Report along with payment of \$150.00. We are respectfully requesting relief for not filing this report by May 1, 2006 for the reasons stated below.

First, because of damages caused by Hurricanes Ivan, Dennis and Katrina during 2004 and 2005, the owner had to close the business as the site is located on Cape San Blas on the Gulf of Mexico in Gulf County, Florida.

Second, the confusion created by who's responsibility it was to file the Annual Report by May 1, 2006 resulted in the discovery by the new accountant of the Annual Report Notice this past week when he commenced preparation of the 2005 Corporation Income Tax Return. As shown on the notice, it was presumed the filing and payment had been handled by the prior accountant. This never took place. Because the prior accountant had filed and paid the fee for the prior year 2005 Annual Report, the owner logically concluded that the prior accountant must have also done so for 2006. (See the enclosed copy of the note the owner sent to the prior accountant.) Therefore, the May 1, 2006 filing date was overlooked.

Accordingly, the owner of The Entrance believes reasonable cause exists in the late filing of the 2006 Annual Report. The owner requests the Department accept the \$150.00 Annual Report fee.
