Ben Hillard: President & Treasurer.      Tambra Hillard: Secretary.

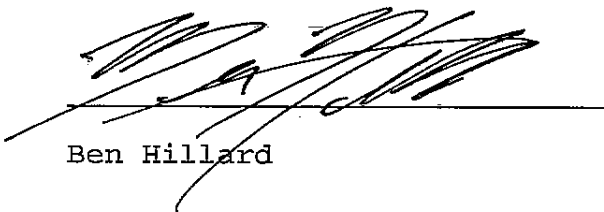
**ARTICLE X - AMENDMENT**

This corporation's Fiscal year shall be the calendar year.

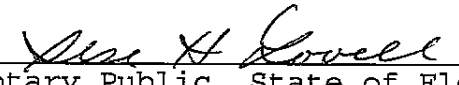
