**ARTICLE I - NAME**

The name of this corporation is SHOW THREADS, INC. The principal address of said corporation is 3737 SE 2<sup>nd</sup> Street, Ocala, Florida 34471.

**ARTICLE II - DURATION**

This Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed to invalidate any contract or other transaction that would otherwise be valid under the common and statutory law applicable to it.



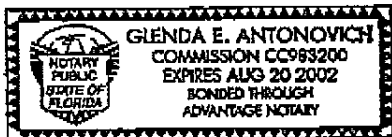
