**ARTICLE I: NAME**

The name of the corporation is: **All Coast Hurricane Protection, Inc.**

**ARTICLE II: NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to do all things which natural persons might lawfully do in the premises as follows: sales and installation of protective shutters, awnings, and other door and window coverings and related products and services and investments of every kind, nature and description.

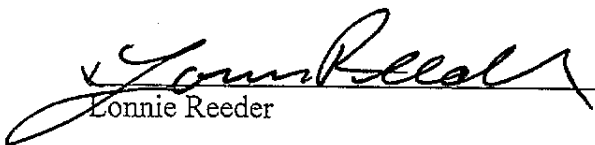

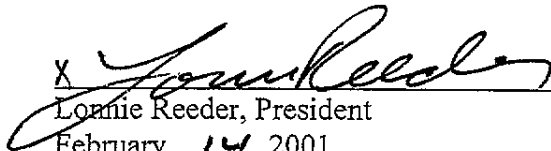
