

ARTICLES OF INCORPORATION
OF

ARTICLE I. CORPORATE NAME

The name of the corporation is: Computer Trauma Center, Inc.

The principal place of business of this Corporation shall be:

ARTICLE II. NATURE OF BUSINESS AND POWERS

ARTICLE IX. AMENDMENT


