The undersigned, acting as Incorporator of DYNAMIC ROOFING, INC. a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the information, liabilities, rights, powers, immunities of a corporation for profit, and do hereby certify:

ARTICLE I

The name of the Corporation shall be DYNAMIC ROOFING, INC.

ARTICLE II

The Corporation shall have perpetual existence.
