
**Article VI- Board of Directors**

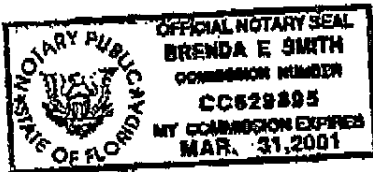




