PH 2: 25 WE, the undersigned, in order to form a Corporation under and pursuant to the provisions of the laws of the State of Florida for the purposes set forth below, hereby subscribe to these Articles of Incorporation.

The name of the corporation shall be CTI DIRECT DISTRIBUTION, INC.

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows:

- To do and transact any and all business as permitted under the laws of the State of Florida and the United States of America.
- To purchase for investment and resale, and to traffic in land, В. property, house and buildings and other property of any nature. To create, sell and deal in freehold and leasehold ground rents. To make advances upon the security of land or houses or other property. To deal in any manner with real and personal property.
- To draw, make, accept, endorse, discount, execute and issue C. promissory notes, bills of exchange and other negotiable instruments, including bonds, debentures or other obligations of this corporation, whether secured by mortgage, pledge or otherwise or unsecured, for money borrowed or in payment for property purchased or acquired or for other lawful objects.
- D.
