The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of this corporation is: RETIREMENT SECURITIES OF SOUTH FLORIDA, INC.

ARTICLE II: NATURE OF BUSINESS

This corporation shall engage in any activity permitted under the laws of the State of Florida, and the United States of America.

ARTICLE III: AUTHORIZED SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: Two Hundred (200) Shares, Single Class, Common Stock, \$1.00 Par Value.

All the aforementioned stock is to be issued as fully paid for.
