

ARTICLES OF INCORPORATION OF BJ WELDING SUPPLY & REPAIRS, INC.



The undersigned subscriber to these Articles of Incorporation, a natural person FLORIDA competent to contract, hereby forms a corporation under the laws of the State of Florida.
