The undersigned incorporator, for the purpose of forming a corporation under Florida Business Corporations Act,

Articles of Incorporation.

## ARTICLE I

#### ALBERTO MOTORS, INC.

## ARTICLE II

This corporation shall commence existence upon the filing of these Articles or Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

### ARTICLE III

The Board of Directors may, from time to time, move the principal office to any other address in Florida. - To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute S607-141;

- To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the Unites States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof;
- To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation
  may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or
