ARTICLES OF INCORPORATION
OF
ANAND INC.

I, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is ANAND INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 9232 Hidden Water Circle, Riverview, Florida 33569. The Directors may from time to time designate such other address and place for the principal office of the corporation, as they deem appropriate.
