ARTICLES OF INCORPORATION

The undersigned Incorporator hereby forms a corporation under the laws of the State of  
Florida:

Article I. Corporate Name.

The name of this Corporation is:

Article II. Mailing Address of Corporation.

The mailing address of this Corporation is c/o Roland Sanchez-Medina Jr., McDermott,  
Will & Emery, 201 S. Biscayne Boulevard, 22nd Floor, Miami, Florida 33131.

Article III. Capital Stock.

The aggregate number of shares of stock that this Corporation is authorized to issue and  
have outstanding at any one time is Ten Million (10,000,000) shares of common stock having a  
par value of \$1.00 per share. The Board of Directors of this Corporation shall have the power  
to divide and issue the Common Stock into one or more series and to determine the limitation  
and relative rights of each such series, consistent with the laws of the State of Florida. Shares of  
one series may be issued as a share dividend in respect of shares of another series.

Article IV. Term of Existence.

This Corporation shall have perpetual existence.

**Article V. Initial Registered Office and Registered Agent.**

The Corporation's initial registered agent shall be Roland Sanchez-Medina Jr., Esq. and the street address of the initial registered office of this Corporation in the State of Florida is c/o McDermott, Will & Emery, 201 S. Biscayne Boulevard, 22nd Floor, Miami, Florida 33131.

**Article VI. Board of Directors.**

This Corporation shall have no directors initially. The number of directors may be increased or decreased from time to time as provided in the Bylaws.

**Article VII. Incorporator.**

The name and street address of the person signing these Articles of Incorporation as the Incorporator is Roland Sanchez-Medina Jr., Esq., 201 S. Biscayne Boulevard, 22nd Floor, Miami, Florida 33131.


**Article VIII. Amendment.**

These Articles of Incorporation may be amended in the manner prescribed by law, except that upon the issuance of shares, every amendment must be approved by the Board of Directors of the Corporation before it is submitted to the shareholders of the Corporation for their approval.

Except as may otherwise be provided in the Bylaws of this Corporation, this Corporation shall indemnify its incorporator, officers and directors to the fullest extent permitted by law either now or hereafter in effect.


