ARTICLES OF INCORPORATION

FOR

ARTICLE ONE

THE NAME OF THE CORPORATION IS D & H STUCCO OF ORLANDO **INC.**

THE PERIOD, TERM AND DURATION IS **PERPETUAL.**

ARTICLE THREE

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS' BUSINESS AS A FULL SERVICE STUCCO AND CONSTRUCTION COMPANY, WHEREAS, WE WILL PROVIDE CONSTRUCTION AND STUCCO OF ALL KINDS. ALSO, THE COMPANY WILL DO ANY OTHER LEGAL BUSINESS AS PROVIDED FOR BY STATUE. ALL OF THE COMPANY'S BUSINESS WILL BE CONDUCTED UNDER THE NAME OF D & H STUCCO **OF ORLANDO INC.**
