**ARTICLE I - NAME

**ARTICLE II - DURATION**

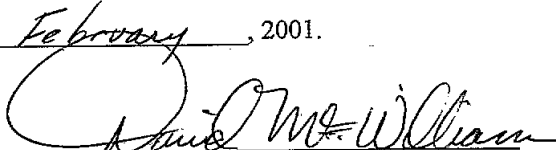
**ARTICLE IX - INDEMNIFICATION**

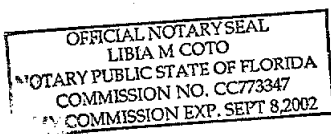
