The undersigned, acting as incorporators of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

Article I - Name

The name of the Corporation shall be J.C. HAIR CREATIONS, INC.

Article II - Principle Office
