ARTICLE I. CORPORATE NAME

ARTICLE III. CAPITAL STOCK

The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred Thousand (100,000) shares of common stock having a par value of \$.001 per share. Corporation before it is submitted to the shareholders of the Corporation for their approval.


ARTICLE IX. INDEMNIFICATION
