The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be:

WORLDWIDE YACHT SERVICES OF FT. LAUDERDALE, INC.

**ARTICLE II. DURATION**

This corporation shall exist perpetually commencing on the day of filing of these Articles of Incorporation with the Department of State.

**ARTICLE III. PURPOSE**

This corporation is organized for the purpose of transacting without limitation, any and all lawful business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE IV. CAPITAL STOCK**




