THE NAME OF THE CORPORATION SHALL BE; LION CONSULTING & MARKETING INC. 947 HAMILTON CT. PALM HARBOR FL 34683.. WE THE UNDERSIGNED INCORPORATOR, BEING A NATURAL PERSON, HEREBY FILES THESE ARTICLES OF INCORPORATION TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I

A.
