# ARTICLE I

The name of this corporation shall be:

# ARTICLE II COMMENCEMENT AND TERM OF EXISTENCE

This corporation shall have perpetual existence; the date of the commencement of said existence shall be the date of the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

# ARTICLE III NATURE OF BUSINESS
