The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article I

Name

The name of the corporation is Godette and Goldstein of Florida, Inc., and the principal address shall be, 3801 N. Longfellow Circle, Hollywood, Fl. 33021

Article II

Duration

The Corporation shall exist perpetually. 
