

a natural person, competent to contract, forms a corporation under the
laws of the State of Florida, and further agrees to the following conditions
of said corporation.

ARTICLE I

NAME

The name of the corporation is: **ZEE, INC.**

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing the
date of the filing of these Articles.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transaction of any
or all lawful business.

ARTICLE IV

AUTHORIZED STOCK
