

ARTICLES OF INCORPORATION

By these ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. NAME:

The name of this corporation is:

SOUTHERN AUTOMATIC REFRIGERATION, INC.

2. TERM:

This corporation shall exist perpetually.

3. PURPOSE:

The purpose of this corporation is to transact any/all lawful business for which corporations may be incorporated under Chapter 607 Florida Statues.
