ARTICLES OF INCORPORATION

of

BIGGZ ENGINEERING & INVESTMENT, INC.

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607, Florida

Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I- NAME AND ADDRESS




