OF

ARTICLE I - NAME

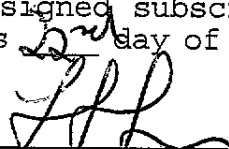
ARTICLE IX - INDEMNIFICATION

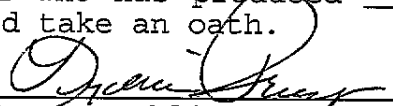
