ARTICLES OF INCORPORATION

Article I

<u>NAME</u>: The name of this corporation will be D. L. Matonis Appraisal Services, Inc.

Article II

PRINCIPAL OFFICE AND MAILING ADDRESS: The principal office and mailing address of this corporation will be:

Article III

<u>PURPOSE</u>: The purpose of this corporation is to provide appraisal services to persons and corporations and any other purpose authorized by law.
